BOARDS OF DIRECTORS :

The Boards of Directors for FEVR and the NRM met June 3, 2009, at the Wilderness Lodge in Fremont. Those in attendance for their respective board positions were Shirley Angermund, George Blessing, Charles L. Sedlacek, Jeff Blackmore, Maynard Porter, Erik Mutthersbough, Dennis Wallen, Al Schlapfer, Darrel Miller (FEVR only), Bob Ubberheim (FEVR only) and Ron Spahni, (FEVR only).

Minutes from the previous **FEVR** and **NRM** meetings and the current treasurer's reports were presented, reviewed, and approved.

Porter reported that all FRA reporting was current as of the meeting date, as well as information about the tree chipper.

Discussion was held concerning the sale of some assets that are not needed for current operations. The large **diesel generator** unit that was formerly a military unit and the Farmall **tractor** that was donated were identified. The generator unit shows very little use, but does not fit needed power requirements and the tractor does not have a live hydraulic lift which limits it usefulness. Both have been in running condition but currently need batteries. It was suggested that both be put in operating condition prior to a sales attempt.

The **boom truck** has issues that make it unsuitable for highway use, but it would be of value in the train yard. Repairs will be made to enable that use.

There are also items in Hooper that need to be reviewed for possible sate and disposal.

Representatives of the Federal Railroad Administration (FRA) were again visitors.

Some things were identified that need priority attention for completion.

One of the **NRM** board members has donated a highway type sickle mower and a rotary shredder ("bush hog") to NRM. Both can be used with the Ford 2N tractor on hand. **Miller** and **Porter** brought the units from the donor's property.

BUSINESS PLAN:

The organization has been without a comprehensive business plan for an extended period of time. A business plan is an essential instrument as the basis of grant proposal writing and in seeking other support.

As a start at addressing this issue, a special meeting of **NRM** BOD members was scheduled for 11:00 AM on Sunday, June 14[•] at the depot.

(The meeting was held as scheduled on the 14^{th} and the product was to be commented upon by the participants and reviewed at the next meeting.)

HOOPER RAIL YARD:

The business plan meeting scheduled for June 28 was cancelled and available help was used in Hooper cutting weeds and trimming brush. Among those assisting were Al Schlapfer, Maynard Porter, Dennis Wallen, P.J. Foster, and David Fachman. THEX recently donated tractor powered shredder was found to work very well.

MAINTENANCE OF WAY:

Al Schlapfer reported track work northeast of county road T. Working with him were Lawrence Addleman and P.J. Foster. OTHER RAILROAD NEWS:

From the **Omaha World-Herald** via the news letter from the **NRHS Great Plains Chapter** (Grand Island): Federal stimulus money has become available for renovation of the Omaha Road depot in Dakota City, NE. The cost was reported to be \$187,627. It will become a museum and trailhead. There were 11 recipients of a total of \$7,067,678 in the fund.

SAFETY IMPROVEMENT ACT:

The Rail Safety Improvement Act of 2008 was passed by Congress in response to reports of rail accidents due to crew fatigue. Among others items, there is now a limitation on the number of consecutive days a crew person can work without rest days and also there is a cap on the total number of hours that may be worked each month in train service. Although aimed at the 24 hr/day, seven day/week Class 1 operations, it also will apply to short lines and probably tourist lines where the work schedules are generally quite different and fatigue is not a major factor. The latter applications may limit the ability of short lines and tourist lines to deliver the customary services.

POSITIVE TRAIN CONTROL (PTC):

The ability to stop a train when needed by automatic control has been mandated by Congress to be installed on many lines carrying passengers or hazardous materials by **2015**.

However, even that may fail, since a malfunction in the automatic train control system appears to be a cause in the recent rearend collision of commuter trains in the Washington, D.C. area.

EXCURSION SEASON:

Excursions are scheduled to continue every Saturday and Sunday until the end of October. Boarding times are at 1:00 PM at the Depot at 1835 N. Somers in Fremont. (See schedule exceptions below) The 15 mile trip takes riders to Nickerson and return and is approximately two to two and one-half hours long. Fares are the same as those for last season and depend on the choice of vintage or climate-controlled coaches
