The NRM Board of Directors met at the Clarion Inn in Fremont on October 5, 2011. Present were Treasurer/Executive Director Angermund, BOD members Daniels (BOD president), Swetnam, Eveland, Blessing (BOD Secretary), and Blackmore.

Not attending: **D. Mutthersbough**, **Powers**, and **Peterson**.

Guests - **Sedlacek**, FLASH editor, **Hunter Lafferty**, **David Fachman**, and **Bruce Eveland** 

Guest **Sedlacek** brought for display an electronic device called a "Battery Minder", which maintains a good storage battery condition in unused vehicles, with the suggestion that it might prove useful to NRM.

He also brought up plans for the possible future **donation** of a Case skid steer loader and transport trailer which he had used doing volunteer work on the railroad. The unit is narrow enough to be able to travel between the rails on the track.

The usefulness of an FRA track inspection was discussed because of the lack of repair by the new track owner (*Editor: see the President's Corner this issue*).

The **accident** on highway 77 where the crossing signal equipment on the center island was demolished by a highway vehicle was reviewed. Needed reports to insurance and the FRA had been executed. There was no involvement with other railroad equipment and train traffic continues.

The pending work on the RPO was discussed (*Editor: see the President's Corner this issue*).

The Treasurer's report was presented and

approved (no debt!).

The process of election of officers on the BOD was begun. The positions currently held by **D. Mutthersbough**, **Porter**, and **Powers** will be on the election ballots. (<u>Powers filled</u> the position vacated by **Wallen** on 12/31/10.)

NRM member **Hunter Lafferty** and BOD members **Swetnam**, **Blessing**, and **Blackmore** were to form the election committee and handle the election work (the invitations for nominations were sent to NRM members in mid-October and are due back prior to the BOD meeting on 11/02/11. Ballots will then be sent to NRM members, due back at the December BOD meeting. Ballots will be accepted only through USPS mail delivery.)

A Constitution/By-Law Committee consisting of NRM members **David Fachman** and **Charles L. Sedlacek** and BOD members **Blessing** and **Blackmore** was appointed to revise the NRM documents. A target date for the draft was to be the March 2012 BOD meeting.

The work done and still needed on the Nickerson passing siding was discussed (Editor: see the article this issue).

#### PRESIDENT'S CORNER:

President **Daniels** writes "Work progresses on the **RPO** car. The brakes have been completely overhauled and are now in "top condition". The roof has been painted with black, waterproof paint to protect it. The black paint restores it to its original color. We are making arrangements to repair the windows. It is most important that we protect the car from the elements during the winter.

I met with **Regie Edmonson** of the Federal Railroad Administration on October 13<sup>th</sup>. I offered to accompany him, **Tom Brown**, and **Scot Elston** during the inspection, but Regie preferred to do the evaluation only with the other inspectors. He said he would call **Mike Williams**. I left him with the "Agreement" and record of "transfer of sale payment". Regie said he would inform me of any situations."

#### **NICKERSON REHAB:**

After weeks of work by NRM members and other helpers, the passing siding track in **Nickerson** is now in use, allowing the locomotive to again lead the train in both directions for excursion and dinner train runs.

This eliminates the need for the "push-pull" operation which is especially hazardous in the winter. NRM extends appreciation to all who helped
